**EMS Budget Committee Report**: Karin Agosta, chair, stated that the committee has not met since the 2017 Expected Case Budget for SJIEMS has been approved.

## **Vote Yes For EMS 2016 Campaign Levy Committee Report Update:**

The report was given by Rebecca Smith, Treasurer of the Committee. She thanked everyone involved with the campaign. Everyone worked hard and was able to submit to the public a lot of important information about SJIEMS and the need to pass this levy. Commissioner Williams thanked the committee for its work early on and for verifying all the information before it went out to the public so the public could make an informed decision with correct information. Commissioner Edwards thanked Dr. Loren Johnson, Jill Johnson, Bob Callegari, and Rebecca Smith for their hard work regardless of the outcome of the vote. Commissioner Harrington thanked the Budget Review Committee and the Levy Committee for their dedicated work. She thought the indorsements were very critical to the campaign that were in the paper. Commissioner Sharp also thanked the Budget Review Committee and the Levy Committee for their hard work during the course of the campaign. Commissioner Schwinge also thanked everyone that worked on the campaign and reminded everyone that so far there had been a low ballot turn in at the elections office. He reminded everyone to turn in their ballots and remind other people to do so as well.

#### **New Business:**

# **EMS Amended 2016 Budget Discussion:**

Chris Compton, CPA from Lake Kennedy McCullough CPA's PS, said that the SJIEMS Amended 2016 Budget was about 85% complete. It is complicated to complete the tie in to the completed Expected Case 2017 SJIEMS budget that has been presented. The budget should be ready for presentation in the August 24, 2016, SJCPHD#1 Board Meeting.

**Res 16-450 EMS Billing Fees & Procedures Change:** This resolution is for changes in the SJIEMS billing procedures for contracting with a new billing company, Systems Design. This resolution will be tabled and presented at the August 24, 2016 Board Meeting.

Res 16-451 EMS Six Year Levy for November 8, 2016 Election Date: This resolution will be filed with the Elections Office. If the SJIEMS levy passes on August 2, 2016, it will be rescinded. Commissioner Schwinge moved that the

resolution 16-451 be passed. Commissioner Edwards seconded the motion to approve resolution 16-451. All in favor - unanimously approved.

**September Board Meeting Date Change Discussion**: The regular board meeting date in September is September 28, 2016. Chief Martin and Superintendent Hutchins both have conflicts with this date. Also the proposed budgets for 2017 will be presented in September. If the meeting date was changed to September 21, 2016, it would also provide an additional week for the public to view the budgets before their approval at the October 26, 2016, Board Meeting. Commissioner Harrington moved to change the September meeting date from September 28<sup>th</sup> to September 21<sup>st</sup> of 2016. Commissioner Edwards seconded the motion. All in favor – unanimously approved.
