Old Business:

The Marine Use of Sentinel contract for costs of use is still at the attorney.

Legal Response to ACLU Letter by SJCPHD#1: The copy of the response to the ACLU by Hospital District Attorney, Brad Berg, is on the back table for review.

Wier Management Solutions, Inc.: Financial Overview, and Wage Extension There are 3 months left until the end of year. The new financial review monthly cost is \$1,200. The Wage Analysis was extended to the end of October.

Commissioner Bayuk asked for a motion to accept both these items,
Commissioner Schwinge --- so moved, seconded by Commissioner
O'Donnell ---, unanimously approved

New Business:

Realtor, Bill Giesey, has filed a rezoning petition and it will be voted on by the Town Council on October 22, 2015. This will change the IIMC from professional services to commercial zoning. This will make the building appeal to a wider audience of potential buyers.

Commissioner Bayuk read a statement from the Board of Commissioners recognizing the work of San Juan Island EMS Staff and Volunteers over the last four months since Chief Jim Cole resigned.

AUDIENCE PARTCIPATION:

Monica Harrington: She was sad about the response to the ACLU letter. Asked on record for each Commissioner to comment on the letter. Commissioner O'Donnell agreed with the letter. Commissioner Schwinge stated it was a matter of legal discussion and looks to the Hospital District Attorney Brad Berg to answer. Commissioner Bayuk stated there are three things the money of the subsidy agreement provides and maternity care services are not one of them. Commissioner Taylor stated that the physicians say they practice as they always have.

Weyshawn Koons: She has been in EMS for 24 years. She thinks there is confusion of who provides the services.

Herb Mason: He had a child born at IIMC. They stopped providing this service because of malpractice costs. Visiting Doctors now provide these checkups.

Beth Williams Gieger: Beth Williams Gieger explained the liability coverage for the staffing model for IIMC. IIMC was a designated rural health clinic and level V trauma center. The staffing model included 4 family practice physicians who provided primary care during business hours and after hours emergency care 24/7 365. This staffing model did not support providing routine obstetric care.

Routine prenatal care, labor and delivery care was referred to visiting specialists who leased space at IIMC.

These same providers are offering the same obstetrical specialty services and labor and delivery services at island hospital in Anacortes. There has been no change in this referral process at PIMC.

Commissioner Bayuk asked for a motion to adjourn. Commissioner O'Donnell---moved to adjourn, seconded by Commissioner Schwinge. All in favor. Meeting adjourned at 5:55---p.m.
